Message to patients: PCMH4U

Richard Roberts, MD, JD Professor, University of Wisconsin Department of Family Medicine, Belleville

A large and growing body of evidence demonstrates consistently that health care systems based on family medicine and primary health care have better outcomes and lower costs than specialist-dominant systems. The Patient-Centered Medical Home (PCMH) was developed to transform and

renew primary care to meet changing societal needs. This session will present the history, promise, and limits of the PCMH. Richard Roberts is Professor and past chair in the Department of Family Medicine at the University of Wisconsin and a past president of the World Organization of Family Doctors and the American Academy of Family Physicians. He has been a teacher and consultant for primary care redesign in more than 50 countries.



In the Community and Around the World: The Contribution of Family Medicine

Cynthia Haq, MD—Professor, Departments of Family Medicine and Population Health Sciences, and Director of the Center for Global Health, University of Wisconsin-Madison, Madison, Wisconsin

Family physicians can apply their skills to promote healthy communities in any environment. Dr. Haq will share stories of how family medicine has strengthened primary health care and transformed the lives of individuals, families, communities. Cindy Haq has provided full spectrum family medicine and has designed and led

medical educational programs in rural Belleville, Madison and Milwaukee WI, and in Pakistan, Uganda and Ethiopia. She trains family medicine residents, provides care for families, the uninsured and homeless, and leads the Training in Urban Medicine and Public Health (TRIUMPH) program for UW medical students in Milwaukee.



The Power of Advocacy and the Role of Family Physicians

Jerry Kruse, MD—CEO and Executive Associate Dean, Southern Illinois University Health Care

Dr. Kruse will share his story on how he started as an advocate at a local area, for rural health and rural health research as well as access to care, and how that led to his role as a "kitchen cabinet" adviser to U.S. Senator Dick Durbin. Find out how students, residents and all family physicians can—and must— participate in

advocacy. You don't have to be a career lobbyist to be a great health care lobbyist! Family physicians at every level, including students, are among the best advocates in the health care legislative arena.

Family Medicine Midwest Awards 2014

Now's the time to think about who inspires family medicine in the Midwest! This is our call for 2014 Family Medicine Midwest Awards!

All 2014 Family Medicine Midwest Awards recipients will be honored during the 2014 Family Medicine Midwest Conference October 9-11 in Minneapolis, Minn. *Travel expenses not included, but any student award winner would be provided a standard FM Midwest scholarship.*

A nomination should include a 2-page maximum letter summarizing the individual's contribution and a copy of the nominee's resume. Nominations will be received through July 31, 2014. The nominations will be reviewed by the Family Medicine Midwest Awards Subcommittee.

The Power To Change Our World Award:

Family Physicians have a long tradition of leadership in the communities in which they live and work. In addition tocaring for patients and families in the office and hospital, they are involved on the local, state, national and international scene. This award recognizes those who have developed innovative projects and programs that have had a positive impact on their world. The Power to Change Our World Award recognizes family physicians, residents and students who have demonstrated significant achievement in promoting the health and well-being of the community, either at the local, state, national or international level.

Nominees must live and/or work in the north central region of the US at the time of nomination. Have designed and implemented innovations that made a significant impact on the health and well-being of the community at large. The nominees should be currently alive and active in their project. Nominations may include recently retired individuals. Their efforts should have had a demonstrable impact on a group or groups of people in the community at large. All nominees must be members of AAFP.

Mid-Career Faculty Achievement Award:

This award will acknowledge one mid-career (five to twelve years of academic experience) faculty member who has demonstrated significant achievement. The intent of this recognition is to honor the upand-coming difference-making faculty who have not yet received tenure approval or otherwise been highly recognized for their efforts. Senior faculty members (i.e., faculty members who have been approved for tenure or who have received substantial recognition from national organizations) should not be nominated for this award.

To be considered for this award, a faculty member may have:

• Written articles, books, manuscripts or other academic materials which reveal a significant intellectual contribution to the field of family medicine and health care delivery;

• Designed and implemented curricular innovations which have made a significant impact on learners such as faculty, residents, students, patients and their family members and/or the community at large. These innovations should include impact studies describing the effectiveness of their intervention;

•Designed and implemented health care programs which have had a measurable impact on those served by the program;

• Designed and implemented research and other scholarly initiatives that have contributed to the scientific inquiry within an area of interest to the field of family medicine;

• Designed and implemented administrative programs that have had a demonstrable effect on the productivity of the organizations where they were implemented.

My Family Medicine Life – Minnesota!

This award will showcase someone living in the host state of the Family Medicine Midwest Conference. For 2014, the Family Medicine Midwest Collaborative is looking for exemplary family medicine stories from Minnesota's family medicine community. **This unique award will be presented to one** <u>Minnesota</u> honoree in each category: student, resident and active family physician.

Tell us YOUR story. This is a self-nominated award. What are the influences that led you to family medicine? How do you now channel your passion to help others improve their health? How do you also inspire others to join your family medicine family?

How do you submit YOUR Family Medicine Life?
